Erin Gullickson requested part of the west end of Main Street be blocked off for a car show to enable those who need easy access from 11:30 am to 2:00 pm on 8/24/22. S. Kathy Huettl commenced with the second reading of Ordinance 6.0506 4/b/1 to amend setbacks for side yards to change from 10' to 5' for commercial lots. S. Adams motioned to approve amendment. C. Swanson second. Vote all aye. m/c/a. The proposed Junk, and Dangerous and Abandoned Building Ordinance have been sent to City Attorney for review.

McLean County offered to sell 2 lots for \$21 to the city, next to 2 lots the city already owns. S. Adams motioned for the city to purchase Original Townsite lots 5-6, Block 9. S. Fritel second. Vote all aye. m/c/a

N. Schneider made motion to remove R. Westman as signer of the library bank accounts and appoint S. Fritel. C. Swanson second. Vote all aye. m/c/a. Amy Hauf recommends Gina Weiss to be appointed for Library Board member. S. Adams motions to appoint Gina Weiss to be on the Library Board. S. Fritel second. Vote all aye. m/c/a.

N. Schneider motioned to remove N. Gullickson from the city Menard's account and Authorize Don Krebsbach and A. Zabka as authorized users. C. Swanson second.

Mayor A. Zabka appoints Nathan Amick of Ackerman-Estvold as city engineer, Ashley Beall as city attorney, and Ryan Oberg as assessor.

Don Krebsbach discussed Fire Hydrant repairs and replacement needed, the city hall foyer tile is still about a month out on completion, the new Bobcat to be purchased is still 2 to 3 months out from delivery, and gravel is needed at the fairgrounds for maintenance.
